Dickinson Municipal Court Bond Schedule - 2023

Effective this date, the Clerk of Dickinson Municipal Court, the Dickinson Police Department, and the Administrator of the Southwest Multi-County Corrections Center are authorized to receive and approve bonds in accordance with the following schedule:

Part I - General Bond Schedule (amounts shown are to be posted in cash)

If after an arrest utilizing a Uniform Traffic Complaint & Summons, an officer determines that release as provided above will not reasonably assure the appearance of the individual, or such release would pose a danger to the community, individuals so charged must post bond in accordance with the following schedule:

Part II - DUI/APC/Refusal Conditions for Release

- 1. For a period of up to 4 hours after arrest, the Defendant may be released from custody after the required bond has been posted, and only to a person meeting the following conditions:
 - a. Age 18 or older
 - b. Not intoxicated (under the influence of drugs or alcohol)
 - c. Agrees in writing to be responsible for the Defendant
- 2. After 4 hours have passed, the Defendant may be released from custody if the required bond has been posted.

Part III - General Conditions

- 1. Bonds received by the Southwest Multi-County Corrections Center shall be transmitted to the Clerk of Municipal Court on a daily basis
- 2. All bonds shall be posted in cash and placed in an envelope that includes the following information:
 - a. Defendant's full name
 - b. Defendant's date of birth
 - c. Defendant's current residence address & phone number
 - d. Full name, address, & phone number of the bond remitter
- 3. All bonds posted shall become the property of the Defendant and may be forfeited or applied to fines/fees at the Court's discretion. The bond remitter should be so advised.
- 4. Students attending Dickinson State University who live in campus housing or have a local address (verified by DSU Student ID or other documents) shall be treated as local for purposes of this schedule <u>during the months of August through May only</u>; otherwise a bond must be posted.
- 5. Any court appearance for Municipal Court must be set on a Thursday as noted on the citation, complaint & summons, or warrant. The Defendant is responsible for contacting the Clerk of Court to confirm future court appearances.

Part IV - Notifications to Court

- 1. An Affidavit of Probable Cause must be submitted to the Municipal Court after first being approved by the City Prosecutor & the Municipal Court Judge for individuals unable to be permitted to reasonable bail within 48 hours of arrest (on weekends/long holidays)
- 2. When an individual cannot post bond and must be seen by the Municipal Court Judge:
 - a. Notify the Clerk of Court as soon as possible on weekdays
- 3. When an arrest occurs on a holiday or weekend and an individual cannot post bond:
 - a. Notify the Municipal Court Judge at his/her home phone number, personal cell, or email

All prior bond schedules of the Court, whether permanent or temporary, are hereby repealed and replaced by this schedule.
